<u>Call to Order/Agenda Approval</u>: Matt called the meeting to order at 6:01, then called for review and approval of the agenda. Bill made a MOTION to approve the Agenda, SECONDED by Stacy, MOTION CARRIED.

Opening Devotion: Pastor Christine read 1 Peter 1:3-9, which was followed by discussion and prayer.

<u>Secretary's Report</u>: Matt called for review and approval of the Minutes of the March 14<sup>th</sup> meeting. Bill made a MOTION to approve the minutes, SECONDED by Chris, MOTION CARRIED.

<u>Treasurer's Report</u>: Debbie reviewed the financial reports and requested Council's approval to transfer \$200,000 from the Mission Investment Fund to a CD-type account for one year to take advantage of rising interest rates. Stacy made a MOTION to approve the transfer, SECONDED by Betty, MOTION CARRIED.

Jeff relayed the Finance Committee's concern about declining funds, noting that expenses have been trimmed as much as possible, and challenged Council, on behalf of the Finance Committee, to create a new committee to find additional sources of income or charge an existing committee with this task.

## **REPORTS**

Youth & Family Ministry Director's Report: Patti presented her report as written.

<u>President's Report</u>: Matt thanked Patti for her efforts on the Palm Sunday pancake breakfast and noted that she and the kids worked hard to make it a successful Youth fundraiser. Matt also reported that he was pleased to see new faces at Sunday services and felt renewed energy within the Congregation.

<u>Youth (Little Lutherans)</u>: Stacy reported that more than 25 children participated in the Palm Sunday Egg Hunt and everyone had a great time.

<u>Learning</u>: Jeff reported that the committee met on April 4<sup>th</sup>. Five children have prepared for their First Communion, three of whom have received it and two of whom will do so at a later date. There are currently six 7<sup>th</sup> graders and six 8<sup>th</sup> graders in Confirmation. The 8<sup>th</sup> graders are working on final projects, which will be displayed soon. They will be confirmed on Reformation Sunday. Vacation Bible School will be held July 18<sup>th</sup> through 20<sup>th</sup> for Kindergarten through 5<sup>th</sup> grades. This year's VBS theme is Pets Unleashed. Bible Study is held the first Thursday of each month.

<u>Fellowship</u>: Joanna reported that the committee met on April 11<sup>th</sup>. They have discussed several possible fellowship activities/events and would like input from the Congregation to help them decide where to focus their efforts. A survey is planned to gather information about the Congregation's preferences. It will be included in the Sunday bulletins as well as the Messenger in May.

It was also noted that the expiration date must be monitored.
