Dear Artists:

The Eagle River Revitalization Program will once again be sponsoring an Artscape for 2020. Banners will once again hang on Wall and Railroad Streets and the brochure will again be promoted as a walking tour. It is a great opportunity to share your talents with the Eagle River community and its visitors. There is no cost to participate and the artist keeps the original artwork.

Artwork will be digitally photographed and reproduced on 24" x 51" banners. The banners will hang from Memorial Day until Veterans Day. Please consider the following when determining what to submit:

- **Any form of artwork** that can be digitally reproduced is acceptable. This includes 3-dimensional art.
- Artwork must be vertical (horizontal art can be submitted if it can be cropped).
- Artwork can be any size but will reproduce better if the proportions are 1 to 2, as it will fill the banner.

In addition to banners, the ERRP will be showcasing the art and artists in full color brochures and on posters.

Artwork must be delivered to the ERRP office on or before February 1, 2020, to qualify, unless alternate arrangements are made. Kitty Sookochoff will be taking the digital photos, so you are guaranteed a professional reproduction. You will be able to pick up your original once it has been photographed.

If your artwork is chosen by one of our sponsors, a recreation of your artwork will be on a banner throughout the summer.
